In addition to the sizeable EPA SARA Title III chemical database included with the SARA module, you can build an extensive chemical library within MIRS™ with the CLE (Chemical List Extension) module. This large chemical library provides a convenient cross check of the your company's materials against various regulated chemical lists.

The CLE add-on supports more than 100 agency lists, a total of over 225,000 chemicals and 19,000 Form R and HAP category chemicals.

Chemical lists are reviewed and verified each year, by A V Systems' regulatory staff. Chemicals additions are incorporated into the CLE and any delisted chemicals are deleted to keep your organization compliant with the latest reporting requirements.

CLE Monthly Updates: You can enable automatic downloading of regulatory list updates at the beginning of each month to keep up-to-the-minute with the latest additions, changes, and deletions from the supported regulatory lists.

- Saves data entry time for the chemicals in the database.
- Provides a cross-check of the facility's chemical components against the agency list of chemicals, so that you know which chemicals you have to report, and under which regulations.
